Description:

This account was established to receive an allocation of fine surcharges to pay for the statewide warrant system costs. The fund will receive 2.5% of the surcharge placed on various fines issued by the courts, but not to exceed the amount appropriated by the Legislature. Money will be appropriated from this fund to Public Safety per UCA 53-5-209. The "Statewide warrant system" means the portion of the state court computer system containing records of criminal warrant information that is accessed by modem from the state mainframe computer [UCA 53-5-209(1)].
