1) After June 30, 1998, all revenues representing the difference between the fees in effect after May 2, 1994, and the fees in effect before February 1, 1994; 2) After June 30, 1998, \$2 of the amount of a fine or bail forfeiture paid for a violation of Title 41, Motor Vehicles.

Description:

The Legislature may appropriate monies from this fund to the administrator of the courts: 1) to repay costs associated with the construction of the court complex that were funded from sources other than revenues provided for under UCA 21-1-5; and 2) to cover operations and maintenance costs on the court complex.

HB 19 (2001 GS) Renumbered the code section creating this fund from 21-1-5 to 78-7-35.

HB 78 (2008 GS) Renumbered and reorganized Title 78.

SB 176 and 184 (2009 GS) Increased small claims and civil filings fees, but did changes in this section of code did not affect this fund.
