It splits SL County twice and Utah County only twice. It maintains the small split of Davis County. It has a very clean line along Redwood Road on the North end of SL County and 1300 West on the South end of SL County. I tried to keep municipalities together in Utah County South of American Fork. It has a rural/urban mix in all four districts. I don't like that but I'm realistic: no map is getting any support from Rs unless it does that.

It isn't as compact as the map we discussed at the last redistricting mtg but it is more compact than any alternative I've seen being discussed in the last few days and it addresses the Speaker's concern. I like it. I think it is significantly better than any alternative I've seen from the Republicans. If the legislators get significant positive feedback from citizens between now and Monday (emails and phone calls), I think we have a shot at altering the current direction my colleagues want to go. Think about what happened with HB 477.

If you like this map, I think you need to have as much pressure and emails as possible before the Monday morning Republican caucuses at the beginning of the special session. If you wait until after the session and a map is adopted (as will likely, or at least possibly, occur during the Monday special session), it will be too late.

We're going to try to issue a press release today to try and get some media interest. I'm also going to be emailing the map to all the members of the House and Senate today or early tomorrow to explain the strengths of the map and see if I can make a direct pitch to them that way.

I'm copying David Garber on this email. David, thank you again for your great work on this map in particular and on redistricting generally. I hope this revision of your map is something that you can support.

Dear Colleague--

As you know, I've had the opportunity to work on the redistricting committee the last few months. It's been a great experience. One of the best things about our efforts on the School Board, Senate and House maps was working across the aisle to put together maps that both Republicans and Democrats felt, for the most part, reflected the redistricting principles we adopted in the Spring. I'm proud of the work the committee and the legislature did on those maps and I'll stand by them against any challenge.

I think we still have a chance to do that same thing in our work on the Congressional map. I write to ask for your support of a Congressional map that I believe represents the most realistic chance of getting both bipartisan and citizen support for our work.

One of the six final maps the redistricting committee focused on was drawn by David Garber from Utah County. David's "Garber D" map was the only citizen map among the final six. I am not a fan of the idea that Utah is best served with four districts mixing urban and rural. But I recognize that support in the legislature for that approach is strong. And among the maps that went with a rural/urban mix in each district, I liked David's the best.

It needed some work to get the population numbers down to a one person deviation but I tweaked it a little bit and presented it last week at our final redistricting committee meeting. In the committee hearing, Speaker Lockhart expressed concern about Utah County being split three ways. So I went in and made a few adjustments to eliminate that problem. You can see the latest version of the Garber D map at <http://www.redistrictutah.com/maps/congress-rep-king-garber-modified-king>.

Here's what I like about this map. First, it splits no county more than two ways. Salt Lake, Utah and Davis counties are each split twice. Every other county is kept whole. We had to split about 21,000 folks from Davis county to make the numbers for District 1 work. The Utah County split is along I-15 through Lehi and American Fork in a way that is very similar to the base map that the committee adopted. In the South part of Utah county we tried to minimize splits of municipalities. The only city South of American Fork that is split is Salem. In Salt Lake county we worked to make the dividing lines between district 2 and the new district 4 as clean as possible. In the North part of the county we followed Redwood road down to I-215 and then moved over to 1300 West until we got to Riverton where the line moves

Representative King,

My name is Spencer Cox and I am a Sanpete County Commissioner. I am sending this email on behalf of the County Commissioners, Mayors, and Citizens of Sanpete County with a proposal and final plea for your help with the current house redistricting effort. As you are keenly aware, 10 years ago there were two counties hurt the most by redistricting: Sanpete County and Tooele County. Unfortunately the House Base Map approved Monday further exacerbates the disparities in those two counties. The new map divides Sanpete County in half, District 73 and District 68, ensuring that Sanpete County will likely never have an elected representative, even though it is by far the largest of the 13 counties between Utah County and Iron County. Unfortunately it appears that Sanpete County, with a population of 28,000 has been divided in half to protect Representatives from Juab County (10,000) and Millard (12,000). Even more frustrating, the two districts wind illogically northward, both taking in large chunks of Juab County and splitting Tooele County. Fortunately, there is a very simple and logical, solution.

Yesterday I submitted map # 55207 (a copy of which is attached here). Rather than attempting to redraw the thousands of meticulous boundaries of the Base map, I have simply combined and rearranged the boundaries of District 68 and 73. Under the new District 73, Sanpete County is kept entirely whole and combined with the population base of Juab County (i.e. Nephi, Mona, etc). It is important to note that the Base Plan Map also divided the Juab population base from the West desert portion of the county, so there is no real change to Juab. This leaves District 68 covering the entirety of Millard County, Western Juab County and the remaining greater Tooele County area. Not only is this map clean and rational, it provides the bulk of the population in each district from the largest counties—Sanpete and Tooele—and remedies 10 years of frustration in the process. Furthermore, it keeps the incumbents in these two districts separate. And yes, there is only a 33 person difference in population between the two Districts, well within the acceptable limits.

Please do not hesitate to contact me if you have any questions. Thank you for your earnest dedication and devotion to our State and this process. And thank you in advance for looking out for Sanpete County,



1. Please explain the general process an idea must go through to eventually become a law.
2. Please comment on the advantages of getting a potential piece of legislation studied during the interim and adopted as a committee bill vs. waiting for the session to be heard?
3. The Rules require each bill to have two committee hearings- one in each house. The advantage of requiring two hearings is that each bill must pass the scrutiny of two committees where testimony is received from the public. Why does the Legislature suspend that rule and allow bills to be passed with only one committee hearing in one house? What would be the downside if such a practice was discontinued? Should it be discontinued?
4. Please comment on each legislator getting up to three "priority" bills. What does that mean?
5. Priority bills and interim committee bills are drafted first. How is it decided which legislator's priority bills get the lowest numbers? Is it as simple as "first in, first out"? Does leadership have priority?
6. Does having a low bill number mean your bill will get a committee hearing before a higher numbered bill?
7. For those in the audience, what can they do to have the greatest impact on a legislator? (get a connection; share your expertise)
8. The legislative rules indicate that the House shall refer any Senate bill with a fiscal note of \$10,000 or more to the House Rules Committee before giving that bill a third reading. Why is that?
9. Under Article 8 section 4 of the Utah Constitution, the legislature has the authority to amend rules of procedure and evidence with a 2/3 vote in both houses.
Recently the Utah Supreme Court approved sweeping changes to the Utah Rules of Civil Procedure, particularly those involving discovery. The nature and extent of discovery is determined by the damages being claimed and reflect the idea that discovery should be "proportional" to the amount of damages being claimed. Cases fall within one of three tiers depending upon the dollar amount of damages being claimed. The first tier is \$50,000 or less and does not allow a single interrogatory (which are one of the least expensive ways to gather information whether you're a plaintiff or a defendant). What do you think about legislation that would amend these rules and allow perhaps up to 5 interrogatories?
10. Explain the importance of a bill's fiscal impact.
11. Explain what a "boxcar" is and whether the practice should be discontinued.
12. Newspapers in the past attempt to rank the most effective legislators based upon the number of bills they pass. Comments?
13. Drug parity legislation would require that insurance cover oral medications, the same as infusions. Many Cancer drugs are oral, but very expensive. However, they offer the individual a better quality life. For those who live in rural areas where infusion centers aren't available it makes a very big difference. The difference between oral vs. infusion from an insurance standpoint is how it is covered. Infusion is covered under medical and oral under pharmaceutical. Many states have enacted statutes and the increase in cost has been shown to be minor. Is Utah exploring the possibility of a drug parity bill and if not, why not?
14. Utah is a member of The Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP) which includes 45 states and is a free voluntary purchasing organization managed by the state of Minnesota. The 2010 statistics indicate an average savings of approx. 23.7% below

- average wholesale for brand name pharmaceuticals and 65% below average wholesale price for generic drugs. Is Utah using it and who does it apply to?
15. There is also a group called the Northwest Prescription Drug Consortium. It is a joint effort by Oregon and Washington to purchase drugs in bulk at lower rates. In 2008, Utah explored getting involved in this.. What's unique about this program is that it covers residents of all ages and incomes, including those "uninsured and underinsured" and provides coverage for some drugs not covered by traditional plans. The individual, at no cost, is given a discount drug prescription card. Medicaid is not included. The savings for Oregon was thought to be up to 17 million a year. For both Washington and Oregon there is a 40% discount on Generic drugs and 16% on brand name drugs. Why hasn't Utah gotten involved with something like this since it is self-funded?
 16. Why not put a medical clinic right next to or attached to the ER of a hospital and require that everyone must go to clinic unless your arrive by ambulance and then you go directly into ER. You could staff the clinic with Residents and triage into the emergency room if necessary. Everybody without insurance would be required to pay something, whether it is a \$1.00 or \$100.
 17. When a bill has been printed in one house, can an identical bill be printed and run in the other house?
 18. What are the hot topics you think you will be addressing in the upcoming session?
 19. How important are lobbyists to the legislative process?
 20. Should lobbyists be prohibited from giving anything at all to legislators- including meals?
 21. If a bill dies in a committee hearing or on the floor of one of the houses, is there a way to resurrect it?
 22. Explain under what circumstances a conference committee is appointed and their purpose?
 23. Most legislators are working people with real jobs in addition to their work for the state- which means they are incredibly busy people-particularly when they are inundated with email, phone calls, invitations, and meetings, What is the most effective way (during session and during interim) to contact a legislator about an issue?
 24. How many emails do you get per day on average during the session?
 25. Every 10 years, lawmakers are charged with adjusting voting district boundaries to reflect population changes identified in the national census. A vote to approve the new changes is scheduled for October 3rd. Do any of you have any thoughts you would like to share? The committee charged with drafting the new boundaries has invited the state's 3 member congressional delegation to join them in their last meeting (which happens to be today) before the vote on Oct. 3rd to present their own proposed maps . Any thoughts on how much weight their ideas will be given?
 26. Any idea what the boundaries for the new fourth seat in Congress will look like? Should the state's fourth Congressional district include all rural areas of the state? What would happen if the Governor vetoed the plan approved on October 3rd?
 27. One of the oft-litigated issues in Utah is whether a personal injury plaintiff may recover the amount of medical expenses that a treating provider bills as opposed to the amount that treating provider accepts as payment in full. If the plaintiff is allowed to recover the amount billed then that higher amount also impacts the amount of general damages the plaintiff may receive.

- What are the panel members' respective opinions on the issue?
- Do you think this issue is something the legislature would be willing to address, or would it prefer appellate court resolution?

28. Regarding health insurance. The exchanges seem to not work because they are too expensive for minimal coverage (e.g. approx. \$700 month, minimum prescription benefit, \$500-1,000 deductible, maternity benefit linked to prescription benefit). What health insurance is available to those individuals who:

- Are between ages of 40-64 who are too young for Medicare and want to keep working but don't want to get on disability or Medicaid
- Are self-employed or a small business owner?

Examples of the problem:

- a. Self-employed wife with chronic medical conditions requiring meds that cost greater than 2k; husband carries health insurance and is laid off (65 can't get a job and on Medicare). They elect Cobra coverage which is about to end, the exchanges don't have a prescription benefit plan that works, what now?
- b. An ER doctor (with a chronic illness requiring meds in excess of 2k) with insurance is forced to retire (52yo) to take care of his sick wife, loses coverage, can't work and not eligible for Medicare. He can't afford his own meds? Exchanges don't help him, what now?
- c. An ER nurse with breast cancer employed at a hospital. She carries the coverage, her husband is a self-employed accountant. Her cancer returns and she needs to retire, but can't because she will lose coverage, exchanges don't work, What now?
