

Thanks for your email. We have been working on the house map today and made a few changes and will be voting on it tonite. Here is my idea on Copperton and the land west of SR111. Initially I was not too happy about the idea and as I think about communities of common interest, we have unincorporated SL County along the west boundary and seems a good fit for 22. We will see more growth along the west foothills and the distance between Magna and Copperton will seem closer as we continue to grow. As District 22 sits now, we have a majority of unincorporated SLCO which to me translates as communities of common interest. The district has increased in size most of which is unpopulated areas with a large portion owned by Rio Tinto. Thank you again for your email. Tomorrow we will tackle the Senate map.


Dear Legislators:
